1. THE CONSULTANT AGREES:

- a) To regularly sell and promote Aloette products.
- b) To sell and deliver, or instruct the company to deliver products to the consumer only and not to others for resale.
- c) To present all Aloette products and information about Aloette in an honest manner and to hold the company harmless from any damages resulting from any misrepresentation.
- d) To file all reports and information required by law and to follow all federal, provincial and municipal laws applicable to her Aloette business status as an Independent Contractor; and to assume all liability for Self-Employment and income taxes due on income earned in connection with her Aloette Business.
- e) To project and maintain the highest standards of integrity, honesty and responsibility in dealing with clients, fellow consultants, managers and the company.
- f) Not to: adulterate or alter the Company's products in any way; reveal or use the Company's trade secrets as to operating procedures in any way other than in connection with her Aloette business; use the Company's trademark or trade names in any type of advertising (except those provided by the company) without prior written approval from the Company; nor incur any debt or obligation on behalf of the Company.
- g) To accept the responsibilities of a Recruiter by sharing the Opportunity with others.
- h) To fulfill all Orientation and Training Qualifications and agrees that the Security Deposit can be cashed by the company for failure to meet the qualifications.

2) THE COMPANY AGREES:

- a) To pay the following rates of commission on a retail sales deliveries of Aloette Cosmetics and accessory items; 25% on Shows, Private Consultations and client re-orders, All commission increases if qualifications met, and 20% of sales of products sold via Special Sale Promotions.
- b) Company reserves the right to change the commission provisions of this Agreement at any time provided the consultant is given at least 10 days notice prior to the change.
- c) To transfer ownership of the Beauty Kit to the Consultant, provided Consultant meets the conditions specified on previous page.
- d) Company retains right to question sales and recruiting performances as it affects this Agreement.
- e) To permit Consultant to purchase Aloette Cosmetics and accessory items at Consultant prices, provided such purchases are made in the Consultant's name and any applicable Consultant discounts are not 'given' to clients by the consultant.
- f) The Company reserves the right to service all Consultant's customers or assign them to be serviced 'if' the consultant does not maintain 'active' status.

THIS IS THE ONLY AGREEMENT BETWEEN THE PARTIES AND DOES NOT CONSTITUTE THE CONSULTANT AS AN EMPLOYEE OF ALOETTE COSMETICS INC. BOTH PARTIES INTEND TO BE LEGALLY BOUND BY THIS AGREEMENT.
